- B) **Cooler**: set point 33°F providing an air temperature range of 33°F to 38°F while in transit. (1.22.b)

Limitation of Carrier's Liability

Carrier Piece Count Obligation 1.14.8 - Shipments accepted by Carrier as pieces tendered and transported on pallets will be tendered for delivery on pallets. Subsequent shortage claims will not be honored if shrink wrap was intact and the correct number of pallets was delivered as tendered.
